Adult day care provides help for families and caregivers responsible for adults who cannot be left home during the day. It is a supervised environment designed to enrich their daily lives that may include group and individual activities, social outings, health monitoring, exercise, etc. Day care participants include adults who are socially inactive or isolated, in need of personal care assistance, are confused or have experienced memory loss or have physical limitations that prevent independent living.

- Unsolicited phone calls requesting your Medicare number
- Charging for services or supplies that you did not receive
- Providing supplies that you or your doctor did not order

WHAT IS ELDER ABUSE?

The abuse of older adults can take many forms and represents a serious, under-reported problem in every community across this country. Abuse is defined in the Adult Protective Services Act (Public Act 519 of 1982) as the harm or threatened harm to an adult's health or welfare caused by another. The term "elder abuse" includes physical abuse, emotional abuse, sexual abuse, neglect and financial exploitation.

Physical and Emotional Abuse

Examples of physical abuse are slapping, hitting, kicking, imposing physical restraints, and other conduct intended to cause physical injury to an elderly person. Some examples of emotional abuse are threatening to withdraw needed care or making humiliating or demeaning remarks toward an elderly person.

Physical abuse also includes sexual abuse, such as inappropriate touching and nonconsensual or forcible sexual activity. An adult has the right to a consensual sexual relationship with another adult; however, these relationships can become abusive if the adult does not have the capacity to turn away unwanted sexual advances or is coerced or threatened into consenting to sexual activity.

Neglect

Neglect is the harm to an adult's health or welfare that is the result of the adult's inability to respond to a harmful situation [self neglect] or the failure of a person who assumes responsibility for a significant aspect of the adult's health or welfare to respond to a harmful situation or to provide adequate food, clothing, shelter, or medical care [caregiver neglect]. An example of caregiver neglect would be leaving an elderly person who is in a wheelchair due to a stroke in front of the TV all day without meals or assistance in getting to the bathroom.

Financial Exploitation

Financial exploitation can include outright theft, misuse of a power of attorney or other breach of a fiduciary duty to manage funds belonging to the adult, or an intentional breach of a promise to repay money or provide services paid for in advance. An example of financial exploitation would be using a power of attorney to withdraw money from an elderly person's bank account and then misappropriating the money for personal benefit instead of for the benefit of the elderly person.

REPORTING ELDER ABUSE

Legal Authority:

Act 519, Public Acts of 1982; MCL 400.11.

When should you report?

You should report if you suspect or have reasonable cause to believe that physical abuse, emotional abuse, sexual abuse, neglect, or financial exploitation of an adult has occurred. A report does not have to be based on eye witness accounts, incriminating statements, or definite proof of abuse. If you suspect elder abuse you should make a report. Any person can make a report. Certain individuals (described in the next paragraph) are required by law to report suspected abuse.

Who is required to report?

All persons who are employed, licensed, registered, or certified to provide health care, education, social welfare, mental health, and other human services; employees of an agency that is licensed to provide such services; physicians; employees of the county medical examiner's office; and law enforcement officers are mandatory reporters and are required to report suspected abuse.

How is the report made?

Report suspected abuse by calling the Adult Protective Services (APS) statewide Centralized Intake Unit: 855-444-3911 (toll-free). The Intake Unit operates 24 hours/day, 7 days/week. A written report may be submitted at the discretion of the reporting person but is not required.

In Genesee County, a report can also be made by calling the Genesee County Sheriff's Elder Abuse Unit at 810-257-3422.

What is the penalty for not reporting it?

If the person is a mandatory reporter and failed to make a report to APS the person may be sued for damages caused by the failure to report and may be liable for a civil fine of \$500.

What is the role of law enforcement in an APS investigation?

Upon request by APS, local law enforcement officers are required to cooperate in an investigation of suspected abuse, neglect or, exploitation. If the APS worker is denied entry to the victim's residence to interview the victim, APS may request the law enforcement agency to seek a search warrant.

SENIOR SCAMS

Scammers, both male and female, frequently call seniors claiming to be a family member, friend, utility company or IRS worker. They may be on your computer through a dating site or even show up at your door. There are many different ways scammers can get access to your money, your home or your identity.

1. Stop. Don't send money.

Never wire money, put money on a prepaid debit card, or send cash to an online love interest. You won't get it back.

- Never give out personal information over the phone, including birthdate, social security number and account numbers.
- Do not throw paperwork containing sensitive information in the trash, shred it.
- Never let strangers in the house to use your phone.
- If information is received over the phone about a family member needing money, confirm the information with other family members before sending the money.
- Don't allow someone to do work for you until you get references and know the price for the entire job.

2. Pass this information on to a friend.

You may not have gotten one of these calls, but chances are you know someone who will get one - if they haven't already.

ESTATE PLANNING

Guardianship and Conservatorship

Did you know that if you do become incapacitated you could become the subject of a Probate Court proceeding? A probate proceeding for your health care and personal decisions is called a **Guardianship**. A probate proceeding for your financial decisions is called a **Conservatorship**. It is a common misunderstanding to believe that your spouse, child or relative can act for you during a disability. ***The truth is, if you have not designated authority to someone in a power of attorney document and cannot make your own personal or medical decisions, your family will have to go to court to obtain that authority.***

Power of Attorney for Health Care and Financial Power of Attorney for Finances

What can be done to avoid having a guardianship or conservatorship over you and still be able to protect yourself in the event of incapacity? A Health Care Power of Attorney allows you to appoint an individual as your patient advocate who can, at the appropriate times, make medical treatment decisions for you. A Financial Power of Attorney allows you to appoint an agent/fiduciary who can assist you with your financial affairs. Both documents are “durable” power of attorneys (POA’S) meaning that the documents will not be affected by a person’s disability or incapacity. Both documents can be revoked at any time by the grantor. POA’s expire with the death of the grantor, by revocation by the grantor or by a court order. ***Creating power of attorney does not take away any authority from the person who signs it.***

Wills

A Will document is your instruction to the probate court about how you would like any probate assets distributed and who will be in charge of that process. This is often a family member or friend. Probate is court supervised distribution of decedent’s assets. The two types of assets that generally require probate are financial assets with no co-owner or beneficiary designated and real estate titled in the decedent’s name alone. There are pros and cons of the probate process and a lot of misinformation out there. There are times when probate can be the easiest and cheapest way to pass assets. There are also situations where the probate process can be avoided, by using a trust or other simpler methods. A qualified estate planning attorney can help you to navigate your options.

Trusts

There are many types of trusts that can be used to accomplish different purposes. For example: you can provide for the future of your special needs loved one without affecting their governmental benefits; providing for education of a child or grandchild and make sure your assets remain in the bloodline. Typically, you are the Trustee, the manager of your Living Trust, just as you are the manager of your assets now, nothing changes. The “revocable” aspect of a Living Trust means you are in control. It means once you create it, you can always change it. You can revoke it or amend all or part of it.

Drawbacks: Creating a trust can be very expensive. Also, you must add any and all new assets acquired as time goes by. Revising or changing the terms of the trust can add additional expense. Also, if certain assets are titled into a trust, they can count against you if you need to apply for Medicaid to help pay for medical care.

Probate Avoidance Planning

In certain situations, the probate process can be avoided by utilizing things like Ladybird deeds, beneficiary designations, and other documents. These methods can be much less expensive than creating a trust. They should be discussed with a qualified estate planning attorney.

Adult Medication Clinic

This Clinic provides a combination of services, including medication administration, medication review and evaluation, AIMS testing, psychiatric evaluation, and health screens. Medication Clinic services are provided by psychiatrists and registered nurses.

The majority of individuals utilizing the Medication Clinic are also receiving services in other mental health, developmental disability, or substance use programs, either internally or from the network provider panel or other community resources.

Assertive Community Treatment (ACT)

The ACT program is designed to provide intensive outreach treatment to adults with serious mental illness so they may live independently and productively in their communities.

Case Management

This GHS staff helps write an individual's plan of service and makes sure the services in that plan are delivered.

- Supported/Integrated Employment services support beneficiaries in obtaining and sustaining competitive employment.
- Skill Building services consists of activities that help consumers increase their economic self-sufficiency and/or engage in meaningful activities, such as work, school, and/or volunteering.
- Respite Care Services assist in maintaining a goal of living in a natural community home and are provided on a short-term, intermittent basis to relieve the beneficiary's family or other primary caregiver(s) from daily stress and care demands during times when they are providing unpaid care.

Clubhouse

Clubhouse Services are programs where members (consumers) and staff work side by side to operate the clubhouse and encourage participation in the greater community. Clubhouse programs focus on fostering recovery, competency, and social supports, as well as vocational skills and opportunities.

Consultative

Consultative Services, which include nursing, dietary, psychology, occupational therapy, and physical therapy. Eligibility for Consultative Services is based on medical necessity.

Social Club

Social Club is a safe space for adults with disabilities to socialize with peers at no cost. Experience field trips, van outings, and a variety of activities every week.

MEDICAID INFORMATION

Medicaid - What is it?

Good health is important to everyone. If you can't afford to pay for medical care right now, Medicaid can make it possible for you to get the care that you need so that you can get healthy – and stay healthy.

Medicaid is available only to certain low-income individuals and families who fit into an eligibility group that is recognized by federal and state law. Medicaid does not pay money to you; instead, it sends payments directly to your health care providers.

Depending on your state's rules, you may also be asked to pay a small part of the cost (co-payment) for some medical services.

Medicaid is a state administered program and each state sets its own guidelines regarding eligibility and services.

Many groups of people are covered by Medicaid. Even within these groups, though, certain requirements must be met. These may include your age, whether you are pregnant, disabled, blind, or aged; your income and resources (like bank accounts, real property, or other items that can be sold for cash); and whether you are a U.S. citizen or a lawfully admitted immigrant. The rules for counting your income and resources vary from state to state and from group to group. There are special rules for those who live in nursing homes and for disabled children living at home.

In general, you should apply for Medicaid if your income is low and you match one of the descriptions of the Eligibility Groups.

(Even if you are not sure whether you qualify, if you or someone in your family needs health care, you should apply for Medicaid and have a qualified caseworker in your state evaluate your situation.)

What is not covered?

Medicaid does not provide medical assistance for all poor persons. Even under the broadest provisions of the Federal statute (except for emergency services for certain persons), the Medicaid program does not provide health care services, even for very poor persons, unless they are in one of the designated eligibility groups. Low income is only one test for Medicaid eligibility; assets and resources are also tested against established thresholds. As noted earlier, categorically needy persons who are eligible for Medicaid may or may not also receive cash assistance from the TANF program or from the SSI program. Medically needy persons who would be categorically eligible except for income or assets may become eligible for Medicaid solely because of excessive medical expenses.

Medicaid is health insurance that helps many people who can't afford medical care pay for some or all of their medical bills.

MEDICARE INFORMATION

Medicare - What is it?

Medicare is health insurance for people age 65 or older, under age 65 with certain disabilities, and any age with permanent kidney failure (called “End-Stage Renal Disease”). You must have entered the United States lawfully and have lived here for 5 years to be eligible for Medicare.

Medicare has two parts:

Medicare Part A (Hospital Insurance)

helps pay for inpatient care you get in a hospital, skilled nursing facility, or hospice, and for home health care if you meet certain conditions. Most people don’t have to pay a monthly premium for Medicare Part A because they, or a spouse, paid Medicare taxes while working in the United States. If you don’t automatically get premium-free Part A, you may still be able to enroll, and pay a premium.

Medicare Part B (Medical Insurance)

helps pay for medically-necessary doctors’ services and other outpatient care. It also pays for some preventive services (like flu shots) to help keep you healthy and some services that keep certain illnesses from getting worse. Most people pay the standard monthly Medicare Part B premium.

You have choices about how you get your Medicare coverage. Here are the two main options:

Original Medicare

Managed by the Federal government, it provides your Medicare Part A and Part B coverage. (You can choose to have either one, or both parts.) You have to pay a deductible, and you are usually charged coinsurance each time you get services.

- You can add Medicare prescription drug coverage (Part D) by joining a Medicare Prescription Drug Plan. Costs and benefits vary by plan.
- You can also choose to buy a Medigap (Medicare Supplement Insurance) policy to help pay some of the health care costs’ “gaps” (like copayments, coinsurances, and deductibles).

Medicare Advantage Plans (called Part C)

You must have both Part A and Part B to join one of these plans. The plans provide all of your Part A and Part B services and generally provide additional services. You usually pay a monthly premium, and copayments that will likely be less than the coinsurance and deductibles under Original Medicare. In most cases, these plans also offer Part D prescription drug coverage. These plans are offered by private insurance companies approved by Medicare. Costs and benefits vary by plan.

Note: Help is available. If you have limited income and resources, you may qualify for help paying your Medicare health care and/or prescription drug coverage costs.

HOME CARE

There are two types of home health care:

1. Skilled Home Health Care – this type of home care is covered by insurance, often times Medicare. Skilled home care provides services by Registered Nurses, Medical Social Workers, Home Health Aides, Physical, Occupational and Speech Therapists. Skilled home care is a service that is provided often after someone has been in the hospital, has had a change in condition, and/or has been diagnosed with a new condition, i.e. high blood pressure, diabetes, injury at home. The goal of skilled home care is to assist the patient and their caregiver to be as independent as possible in a home setting. This service does require a physician order.

2. Private Duty Home Care – this type of home care is primarily paid for by the person receiving the services. Some people have long term care policies or another type of insurance that would cover private home care. Private duty services often entail someone coming to the home and staying for several hours. The person may assist the patient with a bath, personal care, meal preparation, light housekeeping, and laundry. Also, private duty can be used for someone who is unable to stay alone. Private duty services can be used for a couple of hours a day or up to 24 hours a days. The following listed agencies are provided to give you a choice of providers.

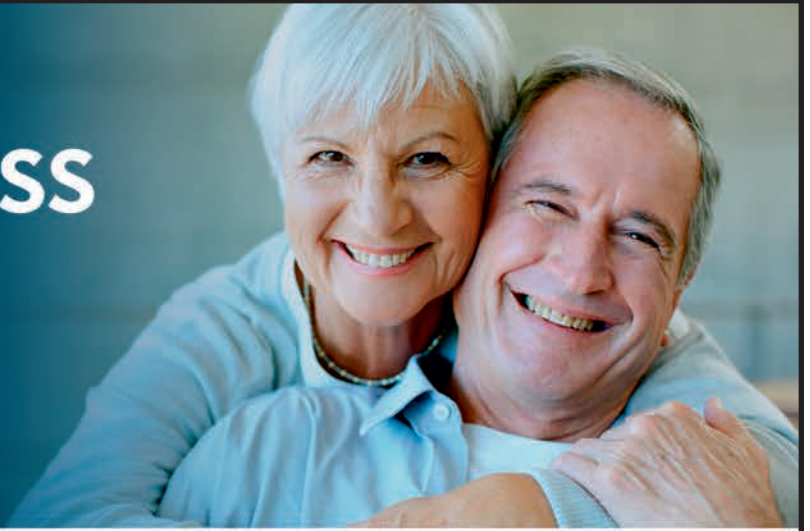

SENIOR HOUSING SECTION

Seniors have numerous life-style choices when they can no longer live at home. Following is a description of the choices and then a listing of local facilities. Keep in mind that the services and amenities offered vary from facility to facility, even within the same group. For example, in ***independent living facilities***, some of them provide extra services like meals or activities, and some do not. Another example is in ***assisted living facilities***, some will accommodate residents in wheelchairs, and some will not. Of course it is always best to thoroughly investigate and compare facilities and ask a lot of questions, in order to match the resident to an appropriate facility.

Independent Living Facilities: These can be government subsidized for people with limited income and assets, or non-subsidized for anyone. They can vary from individual apartments with no additional services, to facilities that provide all meals and activities, and everything in between. Usually there would not be 24 hour supervision, although home care agencies can be contracted to provide extra care as needed for personal care, medications, food, or companionship.

Assisted Living Facilities: These facilities usually have between six to 40 residents and includes 24-hour supervision of the residents. These facilities would offer help with activities of daily living, feeding, dressing, personal care, medications and so forth. These facilities would take care of all the resident's needs up until the time they would need a nursing home.

Memory Impaired Facilities: These are like assisted living facilities that specialize in residents who are afflicted with dementia and Alzheimer's disease. There should be close supervision, and there may be locked or alarmed doors for the resident's safety.

Nursing Homes: These would serve patients who need constant skilled nursing services that are unable to be provided at an assisted living or foster care facility. Also nursing homes can provide rehabilitation for patient's injuries with the hope of returning home or to an independent living or assisted living facility.

These are the categories we have listed in this directory, but in fact there is a lot of overlap of services and different levels of care offered from one facility to another.

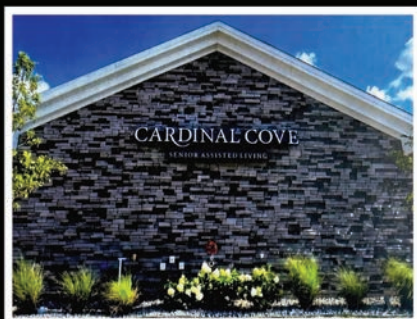

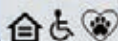

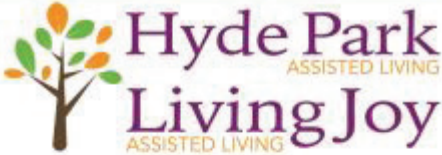
